ORDER

Kerala State Cashew Workers Apex Industrial Co-operative Society Ltd (CAPEX) was allocated an amount of ₹ 350 lakh (Rupees Three Hundred and Fifty Lakh Only) in the State Budget for the financial year 2022-23 for the proposal 'Modernisation and Partial Mechanisation of Cashew Factories of CAPEX' under H/A '4851-00-195-99'. As per the letter read as Ist paper above, the Managing Director, Kerala State Cashew Workers Apex Industrial Co-operative Society Ltd (CAPEX) has requested Government to accord Administrative Sanction for ₹ 350 lakh (Rupees Three Hundred and Fifty Lakh Only) for implementing the said project.

2) The Second Departmental Working Group meeting held on 07/07/2022 considered and approved the above proposal for Administrative Sanction for an amount of ₹ 350 lakh (Rupees Three Hundred and Fifty Lakh Only) by meeting the expenditure from the Head of Account '4851-00-195-99' with the following observations for future compliance:

- (i) The current proposal of modernization and partial mechanization lay stress on maintenance/upgradation of existing factories. More importance must be given to modernization and partial mechanization for improved productivity in the Sector.
- (ii) For monitoring civil construction works undertaken in factories, the committee mooted to set up a Technical Evaluation Committee which would evaluate the progress of works at regular intervals.

3) Government have examined the matter in detail and are pleased to accord administrative sanction for the proposal 'Modernisation and Partial Mechanisation of Cashew Factories of CAPEX' for an amount of ₹ 350 Lakh (Rupees Three Hundred and Fifty Lakh Only) by meeting the expenditure from

the Head of Account '4851-00-195-99' subject to the following conditions for future compliance.

(i) The current proposal of modernization and partial mechanization lay stress on maintenance/upgradation of existing factories. More importance must be given to modernization and partial mechanization for improved productivity in the Sector.
