ORDER

As per Order read as 1st above, Government accorded sanction for the Entrepreneur Support Scheme (ESS) and approved the Guidelines for the Scheme aiming to support the MSMEs in the state engaged in the manufacturing activities.

- 2) The Director of Industries and Commerce as per letter read above, has reported that the ESS State Level Committee in its meeting held on 17/01/2023 has recommended to include Polybutylene Adipate Terephthalate (PBAT) in the category of Biodegradable Plastic Industries mentioned in Serial No.7 of Annexure1 of the ESS Guidelines and furnished a proposal for amending the Guidelines of ESS accordingly.
- 3) Government have examined the matter in detail and are pleased to amend Serial No.7 of Annexure I (List of industries under priority sector) of the ESS Guidelines approved as per Government Order read as 1st above by adding Polybutylene Adipate Terepthalate (PBAT) in the list Bio-degradable Plastic Industries, as follows.
