### ORDER

As per Government orders read above, Administrative Sanction was accorded for a total amount of Rs.3900 Lakh for various project components of the scheme of Local Economic Development and Sustainability of Enterprises under the Head of Account 2851-00-102-98 for the year 2023-24.

2) Subsequently as per letter read above, the Director of Industries and Commerce has submitted proposal in respect of GST provision for 2 project components under the Scheme of Local Economic Development and Sustainability of Enterprises as detailed below and requested to accord Administrative sanction for the required amount of Rs.19,86,000 (Rupees Nineteen Lakh and Eighty Six Thousand only) meeting the expenditure through re-appropriation to the Head of Account 2851-00-102-98(P) from the Head of Account 2851-00-102-07(07) State Sponsored Cluster Development Programme

(SSCDR).
