ORDER

The Director of Handloom and Textiles as per the letter read as 1 st paper above submitted a proposal for administrative sanction for IT Hardware and Software Infrastructure Training and Studies under the scheme for Training and Skill Development Programme.

2) The Director of Handloom and Textiles has reported that in connection with the implementation of the E-Office system and E-Governance initiatives of the Handloom and Textiles Directorate, procure/purchase, upkeep and maintenance of IT infrastructure plays critical role. It is also reported that Directorate of Handloom and Textiles introduced an Online service software management system for processing the new initiatives like K-FON, e-Anumathi etc, through online mode and also developed "Handsum Software" for implementing handloom school uniform project. Modification, updation and finalizaiton of these softwares and development of mobile application platform are also required. As part of implementation of the online processing modules, KSWAN connection is to be provided to Handloom Co-operative inspectors and other supervising officials and where KSWAN is not available for processing through online platform, provision for accessing broadband internet connections has to be provided.

- 3) Director of Handloom and Textiles has further reported that the upkeep and maintenance of IT infrastructure, which is a component of this proposal is essential for the smooth functioning of E-Office. The training component in the proposal includes various training to both Department and Society Staff. It includes training associated with various institutes like Indian Institute of Cooperative Management, Indian Institute of Handloom Management, Centre for Management Development etc, trainings done directly by Directorate of Handloom and Textiles/subordinate offices and various software related trainings to Department and society staffs.
- 4) The Director of Handloom and Textiles has requested to sanction an amount of Rs.37 lakh for the proposal for IT Hardware and Software Infrastructure Training and Studies under the scheme for Training and Skill Development Programme.
- 5)There is a Budget provision of Rs.290 lakh for the year 2023-2024 under the head of account 2851-00-103-74(P) for the Scheme Training and Skill Development Programme.
- 6)The Departmental Working Group Meeting of Industries Department held on 05/05/2023 considered the proposal for IT Hardware and Software Infrastructure Training and Studies under the scheme for Training and Skill Development Programme and recommended for issuing Administrative Sanction for an amount of Rs.37 lakh from the head of account 2851-00-103-74(P) for the proposal.
- 7) In pursuance of the above, Government are pleased to accord Administrative Sanction for the proposal for IT Hardware and Software Infrastructure Training and Studies under the scheme for Training and Skill Development Programme for an amount of Rs. 37,00,000/-(Rupees Thirty Seven lakh only) debiting the expenditure under the head of account 2851-00-103-74(P) from the current year's budget provision.
