ORDER

Director of Handloom and Textiles as per letter read above submitted a proposal for preliminary work including tender formalities for selecting Project Management Consultancy, for preparing DPR for Kanjirode Kaithari Gramam under the Scheme for 'Kaithari Gramam/Handloom Village' at Kanjirode.

(2) Director of Handloom and Textiles has reported that the objective of the Scheme is to establish a comprehensive Handloom Village in the land owned by Kanjirode Handloom Weavers Co-operative Society, Kanjirode, Kannur. The establishment of the proposed integrated handloom village will enable the production, exhibition and sale of handloom products from different States which will facilitate the village as tourist destination. The involvement of handloom weavers from various weaving zones and their products will energize the sharing of knowledge and the development of the handloom sector. It will be a platform for weavers of the State to acquire afresh knowledge and training.

(3) Director of Handloom and Textiles has requested to sanction an amount of Rs. 5 lakh for the proposal for preliminary work including tender formalities for selecting Project Management Consultancy, for preparing Detailed Project Report for Kanjirode Kaithari Gramam under the Scheme for 'Kaithari Gramam/Handloom Village' at Kanjirode.

(4) There is a Budget provision of Rs 233 lakh for the year 2024-2025

under the head of account 2851-00-103-23(P) for 'Kaithari Gramam/Handloom village' at Kanjirode.

(5) The Departmental Working Group Meeting of Industries Department held on 14/11/2024 considered the proposal for an amount of Rs.5 lakh for the preliminary work including tender formalities for selecting Project Management Consultancy, for preparing Detailed Project Report for Kanjirode Kaithari Gramam under the Scheme for 'Kaithari Gramam/Handloom Village' and recommended for issuing Administrative Sanction for the proposal on the condition that the Administrative Sanction amount should be limited within 50% of the overall plan allocation of Industries Department as per plan prioritization.

(6) Government have examined the recommendation of the Departmental Working Group and are pleased to accord Administrative Sanction for the proposal for preliminary work including tender formalities for selecting Project Management Consultancy, for preparing Detailed Project Report for Kanjirode Kaithari Gramam under the Scheme 'Kaithari Gramam/Handloom Village' at Kanjirode for an amount of **Rs.5,00,000/- (Rupees Five Lakh only) by debiting the amount from the head of account 2851-00-103-23(P)** from the current year's budget provision, and limiting the amount within 50% of the overall plan allocation of Industries Department as per plan prioritization.
