ORDER

As per GO read as 1st paper above, sanction was accorded to re-appropriate an amount of Rs. 32.5 Crores from the head of account 4885-60-800-86 of Kerala Industrial Infrastructure Development Corporation (KINFRA) and an amount of Rs. 6.5 Crores from the budget allocation of Kerala State Industrial Development Corporation Limited (KSIDC) to the "Investment Promotion Scheme" under the Head of Account 2885-60-190-91(P), for meeting the invest promotion activities of KSIDC including Invest Kerala Global Summit-2025 subject to the condition that the overall prioritization of Industries Department is limited to 50% as per the Plan Prioritisation proposal approved by the Secretary level committee for Plan Prioritisation 2024-25.
