ORDER

Sri.M.K.Salim, General Manager, Kerala State Textile Corporation Ltd was appointed as Managing Director of Malappuram Co-operative Spinning Mill, on deputation basis. Sri.M.K.Salim was also given the additional charge of Managing Director, Kerala State Co-Operative Textile Federation Limited (TEXFED). Sri.M.K. Salim retired from service as General Manager, Kerala State Textile Corporation Ltd on 31.05.2024 on superannuation.

(2) As per letter read as 1st paper above, Chairman, Malappuram Cooperative Spinning Mill requested that many activities have been carried out effectively in Malappuram Co-operative Spinning Mill through the service of Sri.M.K.Salim and hence he may be allowed to continue as the Managing Director of Malappuram Co-operative Spinning Mill.

- (3) Director of Handloom and Textiles and Chairman, Board for Public Sector Transformation (BPT), as per above cited references 2nd and 3rd respectively, have informed that Malappuram Co-operative Spinning Mill had good performance and profitability during the period 2020-21 & 2021-22 under Sri.M.K.Salim and the State Government award for the best Public Sector Organization for the year 2022-23 has been announced for the Mill. Chairman, BPT has also recommended to extend the service of Sri.M.K.Salim from 31.05.2024 as requested by the Chairman, Malappuram Co-operative Spinning Mill.
- (4) The Kerala Public Enterprises (Selection & Recruitment) Board has been directed to select a new Managing Director to the post of TEXFED. When new Managing Director is appointed in TEXFED, the matter of giving additional charge of Malappuram Co-operative Spinning Mill will also be considered. It may take some more time to complete the said procedures.
- (5) Government have examined the matter in detail and are pleased to reappoint Sri.M.K.Salim, who retired from service on 31/05/2024, as Managing Director of Malappuram Co-operative Spinning Mill and TEXFED, till the appointment of new Managing Directors in both the institutions or for 6 months, whichever is earlier.
