ORDER

The Director of Handloom and Textiles as per letter read as 1st paper above submitted a proposal for "Implementation of Kaithary Suraksha Scheme and Office Automation" for Kerala State Handloom Weavers Co-operative Society (HANTEX) under the Scheme Government Share Participation to HANTEX.

(2)The Director of Handloom and Textiles has reported that a scheme namely "Kaithary Suraksha Scheme" is formulated for rejuvenation of the business and administration of HANTEX. The said scheme ensures

premium quality cloth production and thereby generating sustainable job opportunities to weavers. Many steps have been taken to bring customers more close to Hantex by introducing customer friendly schemes like privilege card, discount schemes, e-credit card scheme, online marketing etc. To achieve the proposed business plan, new innovative and diversified products have to be introduced in the Market. As part of this 785 nos of looms have to be adopted for the production of premium products. It is also reported that to revamp the current software application with latest technology it is proposed to integrate additional features in the software module on existing procurement planning and society management, stock inventory and logistics, marketing management.
