As per the note read above, it has been informed that the Central shares/reimbursements/arrears under various Centrally Sponsored Schemes, Central Sector schemes and other Central Assistance, are yet to be released from Government of India due to various reasons such as non completion of projects in the stipulated time limit, late submission of Utilization Certificates etc. In the meeting chaired by the Hon'ble Chief Minister, it was decided to resolve the pending issues in central schemes/projects on a war footing basis so as to avail maximum central assistance to the State.

2) A total of 20 Centrally Sponsored Schemes/Central Sector Schemes are being implemented by various departments/agencies under the Industries Department. Hence for the timely and proper implementation of the Centrally Sponsored Schemes/Central Sector Schemes, the Heads of Department were requested to nominate suitable officers from each department as Nodal Officers. All the Heads of Departments have furnished nominations accordingly.

3) Government have examined the matter and are pleased to appoint the following officers as Nodal officers of various Departments/ Agencies for the implementation of the Centrally Sponsored Schemes/Central Sector Schemes.
