### ORDER

The Managing Director, KSIDC, in the letter cited above, has informed that several investment proposals in the State - particularly those monitored by the Kerala State Single Window Clearance Board and those received through Expressions of Interest (EOIs) during the Invest Kerala Global Summit - are currently at various stages of implementation. A significant number of these projects involve land-related issues that necessitate active coordination with the respective district administrations. It has been pointed out that the absence of a dedicated institutional mechanism at the district level is adversely affecting the effective follow-up and facilitation of these projects. In view of this, the Managing Director has requested the Government to consider constituting Collector's Investment Facilitation Cells in all districts of the State.

2. Government have examined the matter in detail and are pleased to constitute Collector's Investment Facilitation Cells in all District Collectorates with the following members,

1. **District Collector(Chairman)**
2. **Deputy Collector**
3. **General Manager, District Industries Centre(Convenor)**
4. **District Planning Officer**
5. **Designated Staff Member from Collectorate**

3. The key responsibilities of the Collector's Investment Facilitation Cell are,

- **To function as a Single Point of Contact for the State Government, Industries Department and Kerala Single Window Clearance Board (KSSWCB) for investment-related matters in the concerned district.**
- **To monitor and ensure compliance with decisions and directives issued during KSSWCB meetings, and to coordinate with relevant departments for timely implementation.**
- **To liaise with line departments and obtain regular updates on the progress and status of investment proposals and infrastructure projects with in the district.**
- **To follow up and facilitate approvals for investment projects that are pending at the Collectorate level.**
