As per the Government Order read 1st paper above the Chief Executive Officer, Kerala Bureau of Industrial Promotion has been designated as Drawing & Disbursing Officer in various Heads of Accounts for the National Bamboo Mission (NBM) Scheme and Pradhan Manthri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme under SNA SPARSH. Now, the Chief Executive Officer, Kerala Bureau of Industrial Promotion has informed that as per PMFME scheme, there is a 100% Government of India contribution and for this, Government has created a new head of Account(2851-00-102-90) and allocated an amount of Rs.1,00,00,000/- (Rupees One crore only).
