Vide read 4th paper above Chief Executive Officer has requested to declare DDOs in connection with the implementation of CSS Schemes 'National Bamboo Mission (NBM)Scheme' under Krishi Yojana of Ministry of Agriculture &Farmer's welfare, Government of India and 'Pradhan Manthri Formation of Micro Enterprises (PMFME) Scheme' of Ministry of Food processing Industries (MoFPI), Government of India.

Government have examined the matter in detail and are pleased to declare Chief Executive Officer, Kerala Bureau of Industrial Promotion (KBIP) as the Drawing & Disbursing Officer in various head of accounts mentioned in the annexure for two schemes: 'National Bamboo Mission (NBM)Scheme' under Krishi Yojana of Ministry of Agriculture &Farmer's welfare, Government of India and 'Pradhan Manthri Formation of Micro Enterprises (PMFME) Scheme' of Ministry of Food processing Industries (MoFPI), Government of India, and permit to do treasury transactions through BIMS only with Sub Treasury, Vikas Bhavan in relaxation to Rule 169 KTC Vol 1, on further condition that this DDO declaration is permitted for one year or till the scheme ends, whichever is earlier.
