ORDER

As per Government Order read as 2nd paper above, sanction was accorded for the revision of pay and allowances of the employees of IIHT, Kannur subject to certain conditions in accordance with the revision of pay & allowances sanctioned to Government employees vide Government Order read as 1st paper above. As per Government Order read as 3rd paper above rate of Special Allowance admissible to differently abled Government employees was enhanced from ₹800 to ₹1000 per month with effect from 01.06.2017.
